# Access to Credit Union Documents

In accordance with the State of Texas Credit Union Department Commission Rule 91.315 subsection C, TxDOT Credit Union shall provide notice to the membership the availability of certain documents related to the credit union's finances and management. The credit union shall post such notice on the website and publish notice at least semiannual in the "Road Runner".

Upon request, a member is entitled to review or received a copy of the most recent version of the following credit union documents:

Balance and Income Statements

Summary of the most recent Annual Supervisory Audit

Written board policy regarding access to articles of incorporation, bylaws, rules, guidelines, board policies and copies thereof

Internal Revenue Service Form 990

Request for documents must be presented in writing to the credit union management. If the member wants to receive the documents by mail, the credit union will mail copies within 1 business day of the request.
