Term Share Certificate Promotion

Are you sitting on some money? Looking for a good investment? Look no further than TxDOT Credit Union. For the month of January 2024, the credit union is offering a 7 month Term Share Certificate (CD) with a 4.50% rate/4.592% apy. This account offers a monthly dividend and 60 day div penalty for early withdrawal. The minimum deposit is \$15,000 and available on new money only. Funds currently on deposit are not eligible for this promotion.

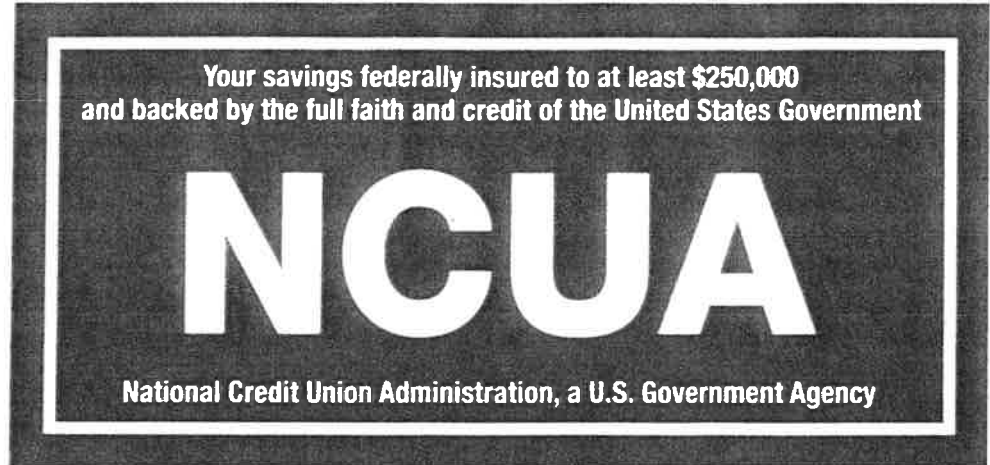

Access to Credit Union Documents

In accordance with the State of Texas Credit Union Department Commission Rule 91.315 sub-section C, TxDOT Credit Union shall provide notice to the membership the availability of certain documents related to the credit union's finances and management. The credit union shall post such notice on the website and publish notice at least semiannually in the "Road Runner".

Upon request, a member is entitled to review or receive a copy of the most recent version of the following credit union documents:

Balance and Income Statements

Summary of the most recent Annual Supervisory Audit

Internal Revenue Service from 990

Written board policy regarding access to articles of incorporation, bylaws, rules, guidelines, board polices and copies thereof

Request for documents must be presented in writing to the credit union management. If the member wants to receive the documents by mail, the credit union will mail copies within 1 business day of the request.
