# \$\$\$ FEE INCREASES ARE COMING \$\$\$

Our fee prices have not changed in over 20 years. The Board of Directors have thoroughly discussed and reviewed market prices. An agreement was reached to raise the amount charged on certain items and products.

Starting September 1, 2024, TxDOT Credit Union will be increasing fees for different services. The fee for late payments on loans will be 5% of the payment due not to exceed \$30. Non-sufficient fund fees and stop payment fees for ACH and Sharedraft/checking items will increase to \$30 per item. For each ATM insufficient funds transaction a \$2.00 fee will be imposed. A check cashing fee in the amount of \$3.00 will be implemented when a member is cashing a check in excess of \$1,000. The average low balance fee for sharedraft/checking accounts will remain at \$5.00 and the monthly ATM card fee will remain at \$1.00.

Some exceptions may apply. If you have any questions in regards to these services and related fees, please contact Toni or Marcy at the Abilene office.


